

Official Rules, Release and Submission Forms

Note: Signed and completed release and submission forms must accompany the artwork to be entered in the contest.

Contest Theme:

In keeping with the theme: Flying Leatherneck Art Contest, your entry should be of Marine aircraft, either past or present, in flight.

Parental Release:

If the entrant is under the age of eighteen (18), they must have the consent of their parent or legal guardian. Please fill out the attached release form, being mindful to fill in all required information. This form should be submitted along with the completed artwork to: Flying Leatherneck Historical Foundation, P.O. Box 45316, San Diego, CA. 92145 or delivered to the Flying Leatherneck Aviation Museum at 4203 Anderson Ave, San Diego, CA. 92145.

Children of persons in positions of command or supervision over the Flying Leatherneck Aviation Museum or the Flying Leatherneck Historical Foundation are not eligible for prizes and awards.

All submissions shall become the sole property of the Flying Leatherneck Historical Foundation and will not be returned. Art will be ineligible if it contains, or appears to contain, in the sole judgement and discretion of the sponsor of the contest, any of the following (1) offensive, profane, obscene or inappropriate material; (2) endorsement of any illegal drug use, alcohol abuse or other illegal activity; (3) nudity, profanity or gratuitous violence; (4) any derogatory characterization of any person or group based on age, race, color, gender, gender identity and expression, sexual orientation, religious beliefs, marital status, mental or physical disability, citizenship, creed, national origin, physical appearance, political affiliation, union membership, or other unethical or unlawful factors; (5) depictions of any conduct, language or other context not in keeping with Sponsor's image or (6) material that defames or invades publicity rights or privacy of any person living or deceased or otherwise infringe upon any person's personal property rights or any other third party rights, including, without limitation, trademark, copyright or other intellectual property rights. Sponsor reserves the right to disqualify any such entry it deems to fail to meet the requirements of these Official Rules. Entrant acknowledge that any breach or violation of these Official Rules, shall immediately disqualify the entrant during any phase of the contest.

Use Rights:

Each entrant irrevocably grants the Flying Leatherneck Historical Foundation and its affiliates, legal representatives, assigns agents and licensees, the unconditional and perpetual right and permission to reproduce, store, copy, publish, post, broadcast, display, adapt, exhibit and/or otherwise use or reuse (without limitation as to when or to the number of times used), as well as to use entrant's name, likeness, photograph and or statements regarding his/her participation in the contest via all forms of media without additional compensation or approval from the entrant or any other party, except where otherwise prohibited by law. Entrant agrees not to sue or assert any claim against the Sponsor for any use of the artwork.
